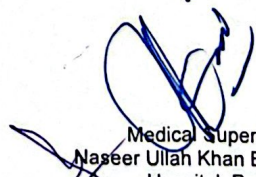

1. Procurement would be carried out through KPPRA Rules 2014.
2. Preference will be given to the local firm/supplier.
3. Firms/supplies/companies can obtain the list along with others terms and conditions from the office of the Medical Superintendent Naseer Ullah Khan Babar Memorial Hospital Peshawar during office hours, which will be provided after written request.
4. Firms/Supplier must have a valid Income Tax, Sales Tax Certificate.
5. The Bidders are requested to give their best and final unit prices as per specifications as mentioned in other terms and condition and no negotiations in the process are allowed.
6. The bid must be valid for 60-days after its submission.
7. Bids/quotation having alternate rates shall be rejected.
8. Envelope of Bid received without specification shall be rejected.
9. Rates should be valid till 30-06-2026.
10. Bid documents must be computerized along with the stamp and signature of the authorized person of the firm and those with hand written, open tag, non-bidding, loose paper and doubtful (misprinting, overwriting and manipulation) will not be accepted.
11. The successful bidder shall sign an agreement deed with the Medical Superintendent.
12. Detail Bidding documents and other requirements are available for the register bidder on KP-EPADS at www.pk.eprocure.gov.pk and our official website www.nkbmh.kpk.gov.com. The scan copy of bids to be uploaded through EPADS and original hard copy of bid security and sealed envelop and original attested stamp paper duly sealed and marked (Name of Tender) must be submitted before the closing date and time, failing to mark the tender name on envelop shall lead to disqualification.
13. Address name of contact person and Phone/Cell Numbers should be clearly mentioned on the envelope.
14. All the financial bids should be submitted in separate envelope.
15. Envelopes must be marked **Confidential** clearly.
16. The Competent Authority has the right to accept or reject any bid as per KPPRA Rules 47 (1).
17. In case of missing any of the above mentioned and other prescribed terms and condition the bid should be rejected.
